The Descendants of Mary Glaves-Turk

June 12, 1746 -March 2, 1835

This Chapter provides additional detail into the descendants of Mary Glaves Turk. Much of the information contained in this chapter has been obtained from the valuable work of other researchers. The degree of documentation in this section is less than that contained in Chapters 1-6. This chapter attempts to establish family lineages to the present day. Many specific references need to be researched further to obtain the definitive proof needed by serious genealogists. References to the Mormon *International Genealogical Index* are especially prone to errors and should be viewed as a starting point and not necessarily documented facts.

We are fortunate to have a letter written by Rudolf. He wrote to James Turk Gleaves on April 25, 1862, shortly after the death of his father. A portion of the letter describing his father's last days is included in Chapter 2. The remainder of the letter follows. Rudolf was serving in the Confederate Army at the time.

"On the 11th of Nov. last I lost my only daughter, a lovely little girl on whom I had placed much of my affections, she died with diphtheria you can better imagine than I can describe my feelings under such a dispensation, I can certainly say "Friend after friend departs who has not lost a friend" – my

other children three boys are very well fine healthy children - the oldest who is in his 15th year is very anxious to go in the Army but I think he is too young – as President Davis said it must be like "grinding the Lead brim (?)"

Our relations here are generally well, I am at this place acting as Assistant Quarter Master having under my charge about 100 men engaged in building waggons and ambulances, also waggon & artillery harness, the Yankee Army in the West is within 15 miles of us & have been within 5 miles of us down the Valley, our people have been very much alarmed, many have moved away, but now they are more composed, how long it will remain no one can tell, as to myself I do not believe they will ever get here, I was ordered to pack up ready to move and loaded a portion of my goods which still are loaded, but the hands are at work finishing up — such work as I can — the Idea to leave ones house to be occupied by such miscreants is horrid, but such may be our fate, yet I have no doubt of the final result

(Here Rudolf reports on three of James Gleaves" sons) I have heard of the death of Junior - I saw him at Manassas a few days after the fight all I have heard from the Dr. is what I have seen in the papers, Robt I understand is commanding a company and I feared he was at Fort Donelson, but have learned since the fight that he was not there, I should be pleased to hear from you – my kind regards to all friends & relations, especially to your afflicted wife, I hope she is enjoying better health than when I saw her, should we never meet again in this world I hope to meet you in Heaven. Goodbye – Yours truly

Elizabeth Robertson's gravestone is in the Old Stone Church cemetery at Fort Defiance, VA (near Staunton). It is reported to say her date of death was 1864, however, this is probably 1854 as her husband, Rudolph remarried on 9 December 1862 to Rebecca Wilson. Also Daryl Turk reports her death in 1854. The tombstone record says the date of death was September 11th at age 33, 4 months, 16 days. Daryl Turk says the date of death was 14 June 1854.

Elizabeth Matthews was Elizabeth Matthews Hull, the widow of Flex Hull, at the time of her marriage.

James' date of birth is recorded in the James Turk Bible.

It appears that James served as a volunteer during the Cherokee War. This is popularly known as the Trail of Tears. Although no official record has been found, a letter written on June 23, 1838, talks about his service under General Scott. He wrote the letter in Calhoun County, Tennessee to his cousin in Wythe County, Virginia, James Turk Gleaves Sr.

Calhoun, Ten. June 28, 1838

Dear cousin,

When I was in your state it was generally believed that a speedy war would be the result with the Cherokees and I anticipated it from the unfavorable rumor. Gen'l Scott it is true is here with several thousand men under his command but the Gen'l and his men are useless in a great measure, as the indians manifest no disposition for hostilities. The indians are coming in daily and delivering themselves to the proper authorities so coercive measures are necessary. Something like two thousand have started for their new homes in the west. Nine hundred are now on their way to Calhoun, destined for the west. Mr. Poinsett, the secretary of War has acted very strongly in attempting singly to modify the treaty of 1835 and what is still more strange Mr. Martin Van Buren has transmitted this strange document to Congress. I am of opinion that Congress cannot legally act on this question without the approbation of Georgia, Alabama, North Carolina and Tennessee, because those states are material(l)y concerned and identified in the Cherokee lands. The time has bin (sic) when many would have rejoiced at a modifi= of the treaty of 35, but the subject is now too nearly matured.

If the Government does not interfere with Gen'l Scott, we will in a very short time succeed in removing the Cherokees west.

Much time and money has already bin (sic) expended in the Cherokee affairs and how when this most desirable object is about to be effectually carried out, the Government attempts to interfere. Strange indeed, strange infatuation, but men who are regardless of the Constitution and of the high functions placed in their hands by their fellow citizens can easily do as they in their great wisdom, may see fit. Instead of Gen'l Scott having to wade through blood and carnage all in perfect peace and composier.(sic)

I am not married yet, but anticipate coming back into your neighborhood this fall, to obtain a wife. I often thing of your wife's advice, and intend to follow it as a near as possible and if I get cheated I will lay all the blame on her. Spring is at least a fortnight earlier in Tenn, than it is in VA. Corn was waist high when I arrived at home. Crops look well generally, all of kind of grain is very high. Corn is worth from 75cs to \$1.50cs in Calhoun fodder worth \$4.00 per hundred.

When I passed Mr. Bians it was raining and I could not conveniently give cousin Samuel a call. John Crowford has returned from Balitmore and is now near his point of death. It is not presumed that he will ever recover. Give my respects to all inquiring relations. Father sends his best respects to all his relations. I want you to write to me and let me know what the times are in VA. I must desist by ending that I am my Dear Sir

Yours with Sincere esteemed Respect Mr J. Turk

James fought for the Confederacy. On July 16, 1861, at the age of 42, he enlisted as a 3rd Corporal in Company C, of the 52nd Virginia Infantry Regiment. Records show that he was promoted to Full 2nd Sergeant on 26 Nov 1861. It appears that he served until February 20, 1863.

James and Sarah appear in the 1870 and 1880 Census for Augusta County. Listed with them are most of their children. He is a farmer.

Sarah is found still in Augusta County during the 1920 Census living with her youngest son Samuel.

In both instances he is living in Bridgewater, Virginia.
